Grant Works representative Ms. Imelda Barrera updated the City Council and the public present at the meeting that The Community Development Grant from 2021 for street improvements and the grant was to reduce the scope of the bid, since it was bided higher than expected. The purpose is to deteriorate road surfaces and lack of drainage resulting in unsafe driving conditions.

Mr. Pedro Gutierrez with Rhyner Construction explained the work to be performed and the location for the update work to be made. It would include Orange Street, Tangerine Street and Woodrow Street.
