This would allow the Task Force to actively participate in the City's effort to respond and comply with the Texas Commission on Environmental Quality (TCEQ) TPDES Phase II Stormwater Rules for the 5th MS4 (municipal separate stormwater sewer system) permit period to begin in 2024.
