WORKSHOP

1. Review Harlingen Waterworks and City of Combes Water Treatment and Delivery of Water Agreement dated June 1984- Rates and Proposed Increase from City of Harlingen Waterworks.

The City Administrator Ms. Aida Guitierrez informed the city council. On March 11, 2024, a copy of the agreement with the City of Harlingen was made available. (A 2nd copy was made available for the workshop). The agreement for the water will expire in June 2024 and the agreement for the wastewater expired in 2016 and is on a month-to-month basis. Contact was made with Mr. Tim Skoglund the General Manager for Harlingen Water Works. Currently retail customers are rates being approved now. Wholesale Customers, which include the City of Combes, an ordinance will be drafted after June 2024 no later than July 2024 for review of ordinance, rates and decide what is agreeable among the city council. The rates at the moment will not be increased as wholesale customers. Discussion related to past and present rates among city officials.

The City Administrator Ms. Aida Gutierrez informed the city council that a report for Building Permit, Municipal Court, Water Works, and Police departments were made available on their packets. Ms. Aida Gutierrez asked for any questions/discussions on items a) to d) to move forward to item e). Commissioner Mary David had a question for the City of Combes Chief Patrick Quill. The question was answered by Chief Patrick Quill.

Mayor Silvestre Garcia asked for any questions/discussions on item a) to d). With no further questions/discussions the City Administrator Ms. Aida Gutierrez gave an update on item e). Updates made by the City Administrator Ms. Aida Gutierrez. She informed the city council that one of the city projects (ARP) American Rescue Plan Project regarding the drainage and pavement of Nixon Rd as of April 04,2024 was seventy two percent (72%) completed. The scheduled completion date has been moved to May 05,2024 and final by May 21,2024 due to two (2) additional 30" pipes that Cameron County Drainage District #5 paid for installation. Payment was received, and payable to Rhyner Construction. No out-of-pocket funds from the city.

Mayor Silvestre Garcia asked the city administrator Ms. Aida Gutierrez to contact the Funding Agency and inquire for Safety purposes if speed humps can be placed on Nixon Road. Ms. Gutierrez provided quote amounts for two (2) different type of speed humps. Mayor Silvestre Garcia asked Ms. Aida Gutierrez to inquire on the amount requirement of speed humps per mile.

The City Administrator Aida Gutierrez Ms. Aida Gutierrez updated the city council on TXCDBG Street for drainage project on Orange and Lime. Rhyner Construction is to start mobilization in the current week and/or by week ending of April 19th. The Contract to expire July 2024. Update: The Home Grant has approved six (6) homes, the building permits have not been acquired due to the Texas Department of Housing are required to

provide the agreements to homeowners to be signed. Once the signatures are obtained and submitted the permits will be obtained to proceed with construction of the homes.

Update: The GLO – The City was awarded \$2 million. Mayor Silvestre Garcia signed contract for First \$1 million to rehabilitate all the manholes. The Second contract 2019 should be received shortly and will be pending for review before being signed. The \$2 million will be used for rehabilitation of manholes and obtain more capacity at lift stations. It covers engineering services, consulting, and construction.

Update: Paving of Woodrow (Aka- Templeton) – The City Engineer Mr. R.E. Garcia provided a notice to contractor MJA to proceed and work to be completed within (90) ninety days. Mayor Silvestre Garcia would like to inform the public that property owners on that street are interested in selling their property after learning about the street improvements. Cameron County was adamant about streetlights having to be relocated, they will not have to be moved.

Update: Valley Baptist Legacy Foundation – City Administrator Ms. Aida Gutierrez applied for a walking trail grant. She was notified the City of Combes is being considered and full application is required to be submitted by May 01,2024. The grant will be used for a walking trail next to the pond to be used by citizens and/or visitors of Combes. Preliminary Plot and design in process by City Engineer R.E. Garcia.

Update: Every County Drainage District working with providing the two (2) 30' RTC pipes that are equivalent to 4x4 box. The capability of not having to reopen and removing the 4x4 box in the future. The City of Combes has been working well with Tx Dot and Cameron County Drainage District to get projects done.
